# Rezoning Request from Ms. Sherri Williams: 130 & 140 Oregon Drive (PPIN 504547 and PPIN 514859) from R-1 to R-2

Ms. Williams stated that she would like to build two duplexes for rental – one on each property. She presented some sample floor plans of the duplexes. She stated that one property was currently vacant and had previously had a home that burnt down, the other was occupied with two trailers. Mr. Seay stated that the town needed more Police/Fire. Mr. Parks asked when did property burn down. Ms. Williams stated she purchased the property after the fire. Discussion amongst the commission was some time in the 2009 timeframe perhaps. Mrs. Parvin stated that she agreed with needing more Police/Fire. Mr. Parks discussed HEMSI shortages in addition to VFD. Mayor Caudle asked Ms. Williams about difference between rezoning from R-1 to R-2 on Oregon vs her previous objection to a similar request on Ervin Ln. Ms. Williams said that if the property owner on Ervin Ln had wanted to do one duplex but that would have been ok, but not ok three. She stated that currently has two trailers, so she's not asking for any more housing units on that lot. The Commission set a Public Hearing date for January 3<sup>rd</sup> at 530PM.
